James graduated from Christian Brothers Academy, Siena College, and Albany Law School. He had a long career with New York State as an attorney and judge. He was currently serving as Principal Hearing Officer for the New York State Office of Administrative Hearings. Jim was a longtime communicant of St. Pius X Church, Loudonville, NY.

He was the cousin Mary Griffin-McDonald, Anthony Pacelli, Father John Kirwin, and the Hughes brothers, Bobby, Frank, Ray, Larry, Peter and Stephen; dear friend of Joan Curry and Kay Connolly.
